Whereas, there is an additional funds tahat is not incorporated under the 2008 fiscal year budgetary appropriations made by the regional council and it is required for expenditure.

Whereas there is unplanned works that could not have been foreseen in the 2008 fiscal year budget appropriations.

NOW, THEREFORE, in accordance with Article 49(3,A) of the revised Constitution of the Ethiopian Somali regional state, the Regional Council hereby proclaimed as follows:

**1, Short Title**

This Proclamation may be cited as the "2008 Fiscal Year of Ethiopian Somali Regional State Supplementary Budget Proclamation No. 164/2016".

5:- The power to administer the Contingency budget of the 2008 fiscal year suplementray is vested to the executive council of the Region, however, provided where encountered budgetary sacristy for the undertaking of water development, for the Health secotr, security affairs and overall natural Catastrophe such as Drought , flood the Regional council authorized the Bureau of Finance and Economic development budgetary transfer from the 2008 Contingency budget for the above purpose, and that Bureau shall report on the utilization and transfers made to the office of President.
